By order dated February 11, 1998, this Court established the Board of Continuing Judicial Education for Supreme Court Justices and District Court Judges in Montana. That order stated that two District Court Judges and one Supreme Court Justice would be appointed by the Montana Supreme Court to serve on the Board for terms of three years, or until their successors are appointed.

In accordance with that order, District Court Judge Katherine Curtis and Supreme Court Justice Jim Regnier were appointed to terms which expire on January 1, 2004. District Judge Mark L. Guenther was appointed to a term which expires on January 1, 2005, however, Judge Guenther passed away while serving in office in November of 2003. It is now necessary to replace District Court Judges Curtis and Guenther and Supreme Court Justice Regnier.

IT IS HEREBY ORDERED that District Judge Loren Tucker is appointed to the Board to fill the remaining term vacated by the death of District Judge Guenther which expires on January 1, 2005. District Judge Julie Macek is appointed to the Board in the position vacated by District Judge Curtis. Judge Macek's term shall expire on January 1, 2007. Justice John Warner is appointed to the term vacated by Justice Jim Regnier. Justice Warner's term will expire on January 1, 2007.

The Clerk of Court is directed to mail a true and correct copy of this order to the Honorable Katherine Curtis; the Honorable John McKeon, President of the Montana Judges Association; District Judge Loren Tucker; District Judge Julie Macek; Robert Sullivan, President of the State Bar of Montana; Court Administrator, Jim Oppedahl; Karen Sedlock, Judicial Educator; and Ed Eck, Dean of the University of Montana School of Law.
