ORDER

The Honorable Julie Macek, Judge of the District Court for the Eighth Judicial District of the State of Montana, has requested the assistance of retired District Judge Thomas McKittrick to assume jurisdiction of the Child Abuse and Neglect calendar, the Youth Court calendar, and initial appearance and arraignment hearings in criminal cases from October 27, 2015, through February 28, 2016.

Judge McKittrick has retired under the provisions of the Montana Judges' Retirement System and, being subject to call for duty pursuant to § 19-5-103, MCA, has advised that he is agreeable to assisting the Eighth Judicial District Court with the above-listed matters.

IT IS HEREBY ORDERED:

1. The Honorable Thomas McKittrick, retired District Judge, is hereby called to active service in the District Court of the Eighth Judicial District of the State of Montana, to conduct all proceedings required by law on Department B initial appearance and arraignment hearings in criminal cases on the above-listed dates, and shall have full authority to conduct all proceedings including the acceptance of pleas and imposition of sentences if necessary.

2. Judge McKittrick shall assume judicial authority of all cases scheduled on the Department B Youth Court calendar on the above-listed dates.

3. Judge McKittrick shall assume judicial authority of all cases scheduled on the Department B Child Abuse and Neglect calendar on the above-listed dates.

4. Judge McKittrick shall have full authority to conduct all proceedings required by law for all Child Abuse and Neglect matters and all Youth Court matters set on the

above-listed dates, including adoption of final orders and judgments, that he determines to be just and necessary.


5. For all active service, Judge McKittrick shall be paid the salary compensation to which he is entitled by § 19-5-103(2)(b), MCA, and actual expenses, if any, shall be reimbursed.

6. A copy of this Order shall be filed with the District Court Clerk of Cascade County, and publically posted for all counsel of record in all cases scheduled on the above-listed dates.

7. A copy of this Order shall be furnished to the Honorable Julie Macek, the Honorable Thomas McKittrick, and to Becky Buska, Office of the Supreme Court Administrator.

This Order is entered by the Chief Justice pursuant to Article VII, Section 6(3) of the 1972 Montana Constitution, and statutes enacted in conformity therewith and in implementation thereof.
