The Honorable Amy Eddy, Judge of the District Court for the Eleventh Judicial District of the State of Montana, has requested the assistance of retired District Judge Katherine R. Curtis to assume jurisdiction of the Law and Motion Calendar, the Youth Court Calendar, the Dependent and Neglect Calendar, and any hearings on August 29 and 31, 2016, and September 2, 2016.

Judge Curtis has retired under the provisions of the Montana Judges' Retirement System and, being subject to call for duty pursuant to § 19-5-103, MCA, has advised that she is agreeable to assisting the Eleventh Judicial District Court with the above-listed matters.

IT IS HEREBY ORDERED:

1. The Honorable Katherine R. Curtis, retired District Judge, is hereby called to active service in the District Court of the Eleventh Judicial District of the State of Montana, to assume judicial authority of the Law and Motion Calendar, the Youth Court Calendar, the Dependent and Neglect Calendar, and any hearings on August 29 and 31, 2016, and September 2, 2016.

2. Judge Curtis shall have full authority to conduct all proceedings required by law for all matters listed above, including adoption of final orders or judgments, which she determines to be just and necessary.


3. For all active service, Judge Curtis shall be paid the salary compensation to which she is entitled by § 19-5-103(2)(b), MCA, and actual expenses, if any, shall be reimbursed.

4. A copy of this Order shall be filed with the District Court Clerk of Flathead County, and publically posted for all counsel of record in all cases scheduled on the above-listed dates.

5. A copy of this Order shall be furnished to the Honorable Amy Eddy, the Honorable Katherine R. Curtis, to Flathead County Court Administrator Marcy Hall, to Kathy Froystad at the Flathead County District Court, and to Becky Buska, Office of the Supreme Court Administrator.

This Order is entered by the Chief Justice pursuant to Article VII, Section 6(3) of the 1972 Montana Constitution, and statutes enacted in conformity therewith and in implementation thereof.
