IN THE MATTER OF CALLING
A SUPREME COURT JUSTICE
TO DISTRICT COURT SERVICE

The Judges of the District Court for the Thirteenth Judicial District of the State of Montana, have requested the assistance of Justice Ingrid Gustafson to assume jurisdiction of the Thirteenth Judicial District Drug Court calendar, the Child Abuse and Neglect calendar for Department 1 on Thursdays from January 11, 2018, to March 29, 2018, and the Criminal Law and Motion calendar on January 12 and 19, 2018. The Judges have also requested assistance with the following individual cases: DR 14-915, DR 17-962, DR 16-1258, DR 17-463, DR 17-704, DR 06-1256, DV 13-1176, and DC 17-1253.

Justice Gustafson being subject to call for duty pursuant to § 19-5-103, MCA, has advised that she is agreeable to assisting the Thirteenth Judicial District Court with the above-listed matters.

IT IS HEREBY ORDERED:

1. The Honorable Ingrid Gustafson, Justice of the Montana Supreme Court, is hereby called to active service in the District Court of the Thirteenth Judicial District of the State of Montana, to conduct the following Department 1 criminal cases on January 12 and 19, 2018, and shall have full authority to conduct all necessary proceedings, including the acceptance of pleas and imposition of sentences.

2. Justice Gustafson may assume judicial authority of all cases scheduled on the Thirteenth Judicial District Drug Court calendar through March 31, 2018.

3. Justice Gustafson may assume judicial authority of all cases scheduled on the Department 1 Child Abuse and Neglect calendar through March 31, 2018.

4. Justice Gustafson may assume judicial authority in the following cases: DR 14-915, DR 17-962, DR 16-1258, DR 17-463, DR 17-704, DR 06-1256,

DV 13-1176, and DC 17-1253 and may have full authority to conduct all necessary proceedings, including final resolution of said cases.

5. For all active service, Justice Gustafson shall not be paid additional salary.

6. A copy of this Order shall be filed with the District Court Clerk of Yellowstone County, and publicly posted for all counsel of record.

7. A copy of this Order shall be furnished to all District Judges in the Thirteenth Judicial District, the Honorable Ingrid Gustafson, and to Cathy Pennie, Office of the Supreme Court Administrator.

This Order is entered by the Chief Justice pursuant to Article VII, Section 6(3) of the 1972 Montana Constitution, and statutes enacted in conformity therewith and in implementation thereof.
