PETITION

COMES NOW GARY ROWE THOMAS and respectfully petitions this Court for reinstatement to active status pursuant to Section 3 of the By-Laws of the State Bar of Montana.

Petitioner was admitted to the State Bar of Montana on January 27, 1983.

Petitioner voluntarily chose inactive status on August 28, 2007.

Petitioner was suspended for nonpayment of bar dues on July 14, 2008.

Petitioner is willing and able to pay active dues, fees, and the state license tax to the State Bar of Montana and comply with any continuing education requirements this Court may impose. In fact, Petitioner has voluntarily paid all bar dues which were due and past due, in the sum or \$610.00, as evidenced by the Receipt for online invoice payment dated September

15, 2009, attached hereto as Exhibit "A" and incorporated herein by this reference as if fully set forth, which, according to the State Bar's website, is the amount necessary to place Petitioner on active status and in good standing once more.

Further, Petitioner has also attached hereto his Continuing Legal Education records from the State Bar of Texas for calendar years 2007, 2008, and 2009 (referred to as Compliance Years 2008, 2009 and 2010 in the attached records). These records are printed out from the Official Website of the Texas State Bar MCLE (Mandatory Continuing Legal Education) and are attached hereto as package Exhibit "B" and incorporated herein as is fully set forth. They reflect Petitioner has the following CLE hours for the following calendar years: 2007: 38.75 hours; 2008: 24.25 hours; 2009 to date: 37.25 hours. Petitioner is also a member in good standing of the College of the State Bar of Texas, as evidenced by the attached email from the Managing Director of the College, attached hereto as Exhibit "C" and incorporated herein as if fully set forth. The requirements for membership in the College are set forth at Requirements for Initial Membership attached hereto as Exhibit "D," and include: 80 hours of CLE in a three year period or 45 hours in the current year, to join the College; then, at least 30 hours of CLE each year thereafter, at least 3 of which must be in legal ethics or professional responsibility.

Petitioner is not currently suspended, disbarred, or otherwise ineligible to practice law in another jurisdiction.

Petitioner is not currently subject to disciplinary proceedings or pending disciplinary proceedings in another jurisdiction.

Petitioner has not been charged with a criminal offense while not on active status. (If so, provide the pertinent details.)

Petitioner has not filed for bankruptcy while not on active status.

Petitioner has not failed to fulfill the obligations of a public office or professional license (other than as an attorney) while not on active status

Finally, petitioner has not committed any acts or omissions while not on active status which would be sanctionable under the Montana Rules of Professional Conduct.

Petitioner would add that he was a proud member of the State Bar of Montana and of the Bar of this Court, having represented clients in something in excess of a dozen cases before this Court, many of which were argued in Helena and one or two elsewhere. It was only the onset of severe financial hardship brought on by illness in the immediate family and other extraordinary factors such as a home flood, open heart surgery, and more, that caused Petitioner to be unable to pay his Bar dues in 2008; nevertheless, it happened, and Petitioner now seeks the relief set forth herein so he may again be an active member of the Bar of the State of Montana.

WHEREFORE, petitioner requests reinstatement as an active member of the State Bar of Montana.

The above statements are true based upon petitioner's knowledge and belief.






