

Pursuant to the Court's Order filed December 23, 2009, Disciplinary Counsel provides the following status report.

On October 19, 2009, the Office of Disciplinary Counsel ("ODC") received a complaint from Teague J. Westrope, Billings Deputy City Attorney. The complaint concerns an appearance by Chris J. Nelson ("Nelson") in Billings Municipal Court while "suspended" from the practice of law. Nelson is being

represented in the disciplinary matter (ODC File No. 09-194) by attorney Robert L. 1 Stephens, Jr. 2 3 ODC has ascertained that in addition to being placed on inactive status on 4 June 27, 2008 for noncompliance with CLE requirements, Nelson was also 5 administratively suspended by the State Bar of Montana on or about July 3, 2008 6 for non-payment of dues. Nelson, in November 2009, paid his arrearages. 7 8 ODC has found five other cases in which Nelson appeared in Montana 9 courts while ineligible to practice law. 10 Rule 5.5, MRPC, states in part: "A lawyer shall not: (a) practice law in a 11 jurisdiction where doing so violates the regulation of the legal profession in that 12 13 jurisdiction[.]" 14 ODC intends to submit this matter to a Review Panel of the Commission on 15 Practice on January 21, 2010. 16 RESPECTFULLY SUBMITTED this <u>30</u>th day of December, 2009. 17 19 20 21 Disciplinary Counsel 22 23 24 25
