immigration detainer issued by U.S. Customs and Border Protection. Plaintiff

Ramon is currently scheduled to go to trial on criminal charges on January 3, 2019. Because there is the possibility that transfer of Plaintiff Ramon to federal custody will impact the justiciability of this appeal (see, e.g. *Valerio Gonzales v. Jarrett*, 2017 Mont.
