The Montana State Auditor, Commissioner of Securities and Insurance (CSI), moves this Court pursuant to Mont. R. App. Pro. 26(2) for an order extending the deadline to file its Answer Brief through Friday, March 6, 2019. The original brief was due on January 4, 2019. The initial extension was granted through Friday, February 4, 2018.<sup>1</sup> The CSI is requesting a 30-day extension.

Settlement discussions between the parties are ongoing and progressing in a manner that indicates the matter will settle. The Appellant is gathering information for review by the CSI, which is necessary to determine the terms of this potential settlement. EXHIBIT A.
