1) COMES NOW, Through Jeffery J. Lout, Currently acting as a PRO SE in the above titled cause; HEREBY FILES THIS NOTICE OF OBJECTIONS TO RESPONDENTS' MAY 3, 2019 EXTENTION OF TIME AND THE COURTS MAY 6, 2019 ORDER: AND A NOTICE TO CONTEST ALL AND ANY FUTURE EXTENTIONS FILED BY THE RESPONDENTS:

SUPPORTING GROUNDS

2) Lout Objects to the Respondents' Third Motion for an EXTENTION OF TIME and hereby gives Notice of CONTESTMENT to any FUTURE EXTENTION OF TIMES; based on the Following Supporting Grounds;

3) The Respondents are The Office of the MONTANA ATTORNEY GENERAL; and as such this OFFICAL OFFICE for the State of Montana employees over 100 Trained and Educated Attorneys that are Licensed to Practice Law with over 50 PARALEGALS, 50

Intrem Paralegals-Law Students; and approximately over 25 LEGAL INVESTIGATORS in which to aid and Assist the Assigned ASSISTANT MONTANA ATTORNEY GENERALS in their Assigned case Loads. Hence Lout Asserts this OFFICE is very well staffed with the needed staff to file and prepare the Respondents' Reply Brief.

4) Lout Asserts: The Office of the Montana Attorney General; has an INHOUSE LEGAL LIBRARY to which the staff and employees has an UNLIMITED ACCESS to go to and to conduct the necessary Research and Draft the needed Reply Brief.

5) Lout Further Asserts: overall: The Office of the Montana Attorney General is fully capable to adequately Research, Prepare and to Draft the Reply brief which was initially due MARCH 6, 2019.

6) Lout Declares that He is a PRO SE LITIGANT in the above titled matter, Lout has no Formal Education or Training in the field of Law, He is currently incarcerated at the MONTANA STATE PRISON to which has been UNDERSTAFFED for over 1½ years, The Lack of Staff has Compelled the MSP Administration to CANCEL the regular PROGRAMING (i.e.: LEGAL LIBRARY ON BOTH HIGH and LOWSIDE COMPOUNDS...); DOC LEGAL BUREAU through Lead Counsel: Colleen Ambrose; has ORDERED that the LAW BOOKS (MCA'S, RULES OF COURTS, and the alike) be fully removed from the Highside LEGAL LIBRARY and that the LOWSIDE LEGAL LIBRARY REMOVE any excess LEGAL BOOKS which Deprive, Restrict and Hamper the MEANINGFUL ACCESS TO THE COURTS of Lout and all other Offenders; as well as the INADEQUATE LEXIS NEXIS PROGRAM, The RESTRICTIONS of any ATTORNEY in which to provide Legal Advise or research for Lout and the Offender Population as a whole; Thus HINDERING THE MEANINGFUL ACCESS to the COURTS.

7) Lout Declares; in Support with the above information that He has only taken (1) one Extension of time to file his OPENING BRIEF, He is a PRO SE uneducated or Trained Litigant, and Yet the Respondents; who are the Office of the Montana Attorney General; Has not been able to timely Research, Prepare or File their

Reply Brief, based on the assignment of an Assistant⁽²⁾ Attorney; who's case load is so EXTENSIVE he needs EXTENTIONS OF TIMES SO HE CAN ATTEND MOCK (PRETEND) COURT HEARINGS; OPPOSED TO FILING THE RESPONDENTS' REPLY BRIEF TO LOUT'S APPEAL WHICH WILL INITIALLY RELEASE LOUT OF HIS UNLAWFUL AND ILLEGAL IMPRISONMENT AND TOTALLY EXONORATE LOUT OF ALL CHARGES DUE TO THE BIAS AND PREJUDICE JUDGE WHO FAILED TO PROPERLY RECUSE OR DISQUALIFY HIMSELF: TO WHICH SHOWS THAT A SEVERE 'MISCARRIAGE OF JUSTICE' HAS INFACT OCCURRED IN LOUT'S CASES: WHICH DOES CONSTITUTE THAT LOUT'S CASES BE IMMEDIATELY EXONORATED, EXPUNGED DUE TO THE "STRUCTURAL DEFECT" caused by the STATES MALICIOUS AND VINDICTIVE PROSECUTION BASED ON LOUT'S 'SEXUAL ORIENTATION'⁽³⁾ and the FAILURE OF THE JUDGE (JEFFREY H. 8) Lout Concludes that the Respondents' 3rd Extention of time to JUNE 12, 2019 MUST be their last extention of time, thus Lout Further Declares that any future MOTIONS FOR EXTENTION OF TIMES or any ORDERS that GRANT THE RESPNDENTS an EXTENTION ANY FURTHER MUST BE TAKEN IN BAD FAITH and Lout Shall RESERVE HIS RIGHT TO FILE A TIMELY OBJECTION TO ANY SAID RULING TO BE TAKEN BEFORE THE U.S. 9th Circuit Court Of Appeals; as Lout has raised the Suffcient Grounds of the 'STRUCTURAL DEFECTS' which has CAUSED A SEVERE 'MISCARRIAGE OF JUSTICE' in both Lout's Cases (DV:99-22 & DV:02-79) Which Shall RELEASE LOUT OF HIS UNLAWFUL and ILLEGAL IMPRISONMENTS and fully EXONORATE LOUT OF ALL CHARGES.


