COMES NOW Rita Cortright, Court Appointed Replacement Receiver for

Lincoln Road RV Park, Inc., by and through her counsel of record, and hereby respectfully presents the report of assets, operations, and financial affairs for the month of May 2019, as required by the District Court's Order dated May 5, 2018.

Attached, for Lincoln Road RV Park, Inc., are a Profit & Loss Report (Exhibit A), a Balance Sheet (Exhibit B), a Check Detail Report (Exhibit C), and a Deposit Detail Report (Exhibit D) for May 2019. Also attached is a list of unpaid invoices for professional services owing as of May 30, 2019 as Exhibit E.

Also attached are the financial reports for the Grand Valley Estates Home

Owners Association, consisting of a Balance Sheet (Exhibit GV-A), a Profit &

Loss Report (Exhibit GV-B), a Deposit Detail Report (Exhibit GV-C), and a Check

Detail Report (Exhibit GV-D) for month end of May 2019.

Pursuant to the District Court's Order, the Replacement Receiver has taken the following actions on behalf of the corporation:

- 1. Reviewed and approved bookkeeper's work to balance the May check register for the Corporation and for Grand Valley Estates;
- 2. E-mail communication with attorney, Candace Payne, regarding income to the LRRVP, Inc. from garnishment of Kim Harrison's state wages;
- 3. Discussions and e-mails with David Baldwin and Candace Payne regarding modifications to the mitigation plan for the GVE Water Use

Permit. The modified permit will allow the HOA to obtain 5.5 acrefeet of water from the Helena Valley Irrigation District over a 90 day period with a reduced injection rate of 15 gpm into the existing infiltration trench.

- Reviewed and approved bookkeeper's payments of May invoices for Grand Valley Estates and for Lincoln Road RV Park, Inc.
- Issued invoices and past due statements for Grand Valley Estates, made deposits for payments made to Grand Valley Estates, and updated Quikbooks for Grand Valley Estates.

In addition, the Attorney for the Replacement Receiver took the following actions on behalf of the Replacement Receiver:

- 1. Telephone conversation with Lee Process Service regarding status of collection actions and garnishment of Kim Harrison's wages;
- 2. E-mail communications with David Baldwin regarding the terms of the modified HOA water use application.

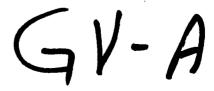

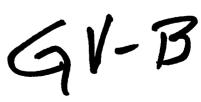
