UNOPPOSED MOTION REGARDING THE DATE FOR FILING INTERVENOR'S BRIEF

On July 22, 2019, Appellees served on the office of the Attorney General a notice pursuant to Mont. R. App. P. 27 that Appellees challenge the constitutionality of Section 27-1-220(3), Mont. Code Ann., which limits an award for punitive damages to the lesser of \$10 million or 3% of a defendant's net worth. On July 24, 2019, pursuant to Mont. R. App. P. 27, Tim Fox, Attorney General, informed the Court and counsel that his office will intervene for the limited purpose of defending the constitutionality of Section 27-1-220(3), Mont. Code Ann.

Because the constitutional challenge is raised in the Appellees' response brief, the briefing timelines for the Intervenor's brief are not entirely

clear. Accordingly, the Attorney General files this motion requesting that his office have until August 23, 2019, to file Intervenor's brief.
