APPELLEE'S UNOPPOSED MOTION TO DISMISS APPEAL WITH PREJUDICE

An Alleged Protected Person

COMES NOW, Linda A. Goldan, Appellee herein, by and through her counsel of record, Dash DeJarnatt, of the Bryan Law Firm, P.C., and respectfully requests this Court dismiss this appeal with prejudice on unopposed motion. On August 21st, Appellant's counsel followed up with Appellee's counsel, V.L.Z.'s attorney, and the court-appointed mediator, Margot Ogburn, indicating that Appellant intended to dismiss this appeal, as shown in **Exhibit A**. On August 27, Appellee's counsel received an email from Appellant's Counsel including Appellant's Notice of Dismissal of Appeal ("Notice"), both the Email and accompanying Notice are attached as **Exhibit B**. Appellee's counsel followed up with Appellant's counsel on September 2nd in an email attached as **Exhibit C** indicating that Appellant had not actually filed anything and that Appellee intended to file this motion today.
