I have received my MCLE Compliance Confirmation letter from the Montana Commission of Continuing Legal Education, which is attached as Exhibit I.


WHEREFORE, petitioner requests reinstatement as an active member of the State Bar of Montana.

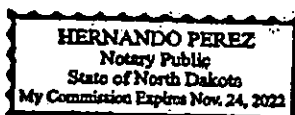
