MOTION TO DISMISS

Defendant/Appellee Oliver Serang, by and through counsel of record, Jessie Lundberg of ASUM Legal Services, hereby moves the Court for dismissal of Plaintiff/Appellant's appeal without prejudice, for the reason that no final judgment has been entered in the District Court case from which she appeals. Counsel for Defendant/Appellee has contacted Plaintiff/Appellant regarding whether she objects to this motion, and she has indicated she does object.

BRIEF IN SUPPORT

Rule 6(1), M.R.A.P., specifies that the Montana Supreme Court may review only the appeal of a final judgment, unless one of the exceptions set forth in M.R.A.P. 6(2) or 6(3) apply. None of those exceptions apply here. Therefore, Plaintiff/Appellant is prohibited from proceeding with an appeal in this matter unless she can demonstrate the District Court has issued a final judgment in the underlying case.

Rule 4(1)(a), M.R.A.P., defines a final judgment as one that conclusively determines the rights of the parties and settles all claims in controversy in an action or proceeding, **including any necessary determination of the amount of costs and attorney fees awarded** or sanction imposed. No such final judgment has yet been entered in this matter. The District Court has merely issued an order granting Defendant/Appellee's motion for summary judgment and denying Plaintiff/

Appellant's motion for summary judgment. However, Rule 6(5)(b), M.R.A.P., expressly states orders denying motions for summary judgment are not appealable.

Based upon the foregoing, Rules 4(1)(a), 6(1), and 6(5)(b) of the M.R.A.P. require dismissal of Plaintiff/Appellant's present appeal without prejudice.
