Petitioner was admitted to the State Bar of Montana on September 1, 1998.

I was placed on inactive status by the State Bar of Montana on August 31, 2020, pursuant to Rules 3B2, 5, and 12, of the Rules for Continuing Legal Education as a result of noncompliance with CLE requirements.

I have all already paid all active dues, fees, and the state license tax to the State Bar of Montana and will comply with any continuing education requirements this Court may impose. In addition, I have paid the late fees and reinstatement fees as required.

WHEREFORE, petitioner requests reinstatement as an active member of the State Bar of Montana.


