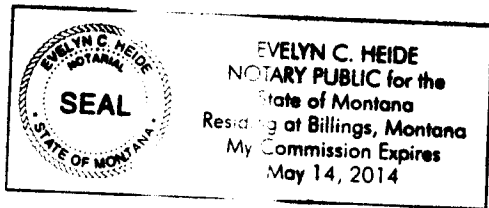

On April 1, 1995, I became employed in a private start-up company in Billings, Montana. The purpose of the company was to commercially develop several patents owned by a Billings inventor.
