**UNOPPOSED MOTION FOR LEAVE TO FILE BRIEF OF *AMICUS*  
*CURIAE* BY THE MONTANA TRIAL LAWYERS ASSOCIATION**

---

Pursuant to Mont. R. App. P. 12(7), the Montana Trial Lawyers Association (MTLA) respectfully moves the Court for leave to file a brief of *amicus curiae* in support of the position of Plaintiff and Appellant Paul Wilke, to be filed on or before the deadline for Appellant's Opening Brief. Counsel for all parties has been contacted and does not object to this motion.

### **Statement of Interest**

MTLA is a member organization of Montana attorneys who represent litigants to secure a just result for the injured, the accused, and those whose rights are jeopardized. MTLA's purpose,<sup>1</sup> in part, is: to uphold and defend the constitutions of Montana and the United States; to promote the administration of justice for the public good, and to advance the cause of those who are damaged in person or property and who must seek redress. These interests are implicated by the substantive underlying dispute between the parties.

### **MTLA's *Amicus* Participation is Desirable**

Longstanding Montana precedent supports an insurer's obligation to disclose policy limits prior to suit. Nonetheless, because the issue has not been explicitly settled, carriers continue to withhold such information from injured third parties. MTLA asserts this issue deserves substantive consideration by Montana Courts and that settlement of the law in favor of such an obligation would promote:

- equality in consumer/insurer negotiations;
- higher rates of pre-suit dispute resolution;
- more accurate claim valuations and settlement amounts;
- a reduction in civil case filings;
- increased judicial resources available for other issues; and
- a net positive effect on the public good.

Given this case's procedural history, however, the *gravamen* of this appeal is mootness. Consequently, the balance of appellate argument will necessarily focus on mootness, not the underlying dispute. The issue of mootness, however, cannot be decided without considering the underlying dispute and related policy concerns. MTLA's *amicus* involvement is desirable because it would enhance the Court's ability to evaluate the potential impacts of its decision on such policy concern.

Accordingly, MTLA should be granted leave to file a brief of *amicus curiae*.
