COMES NOW Christopher Gallus and respectfully petitions this Court for reinstatement to active status pursuant to Section 3 of the By-Laws of the State Bar of Montana. Petitioner was admitted to the State Bar of Montana on September 26, 1996.

Petitioner was placed on inactive status by the State Bar of Montana pursuant to Rules 3B2, 5, and 12, of the Rules for Continuing Legal Education on (July 12, 2021) as a result of noncompliance with CLE requirements.

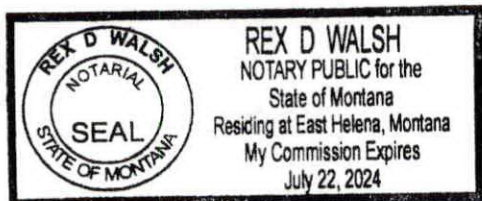

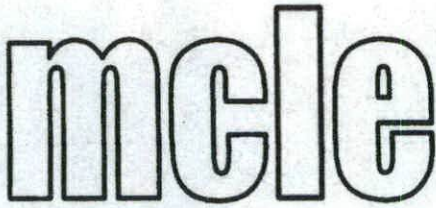
