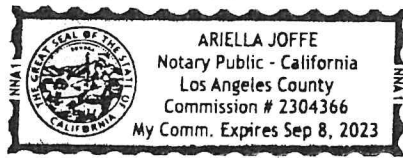



I accrued delinquent debt or filed for bankruptcy while not on active status. Specifically, on 07/31/2017 I filed a voluntary petition under 11 U.S. Code Chapter 7 in the United States Bankruptcy Court for the Central District of California, case number 2:17-bk-19343-BB.
