COMES NOW Appellant, JOHN ARONOW HOAG with his Unopposed Motion for Extension of Time pursuant to Mont. R. App. P. 26(1).

Under Rule 7(3)(a) of the Montana Rules of Appellate Procedure, the parties have 75 days after filing a notice of appeal to complete the mediation process.

Pursuant to Mont. R. App. P. 26(1), upon motion, the Supreme Court may extend any deadline for good cause. The Notice of Appeal was filed on July 13, 2022. Seventy-five days after this date is September 26, 2022.

Appellant requests an extension of time to complete mediation under Rule 7(a)(3) until Friday, October 7, 2022. The parties are unable to prepare for and attend a mediation prior to the 75-day deadline but have confirmed their availability for October 6, 2022. The proposed extension will allow the parties and mediator to comply with Rule 7. The parties do not seek a lengthy or indefinite delay. Given that the mediation has been scheduled on October 6, 2022, and has been agreed upon by both parties and the mediator, there is good cause to grant the extension of time.

Opposing counsel has been contacted and does not oppose this motion.
