Flores-Ortega, 528 u.s. 470, 471, 120 S.C. 1029, 145 L. Ed. 2d 985 (2000) (citing Rodriquez v. Umited States, 395 U.S. 327, 89 S.C. 1715, 23 L. Ed. 2d 340 (1969); Reguero v. United States, 526 u.s. 23, 119 S.C. 961, 143 L. Ed. 2d 18 (1999)].
