Enclosed please find the pass/fail results of the July 2010 bar exam. These results show that 131 examinees sat for the July 2010 bar examination. Out of the 131 examinees sitting, 121 examinees passed the exam and 10 examinees failed.

109 examinees are currently eligible to be Sworn-in once their dues are paid to the State Bar of Montana. 12 passing examinees listed must still obtain their MPRE requirement and will then be eligible. Names of the 121 examinees who passed will be listed on the State Bar of Montana's website now that the Court has been notified of the results.
