DISQUALIFICATION OF
JUSTICE(S) AND REQUEST FOR
DISCLOSURE OF OTHERS

Appellant, Anthony weimer, hereby disqualifies Justice Mike McGrath from hearing or deciding matters in this appeal. Pursuant to 3-1-803(1), MCA, Justices must not sit or act in any action or proceeding to which he is interested. Pursuant to MONTANA CODE OF JUDICIAL CONDUCT (MCJC) Rule 2.12, a judge is obligated to not hear ordecide matters regardless of whether a motion is filed when a judges impartiality is reasonably questioned. The following grounds provide for disqualification of the aforementioned justice: (1) Weimer filed a notice of disqualification of district judge, Heidi Ulbricht, in this matter. Justice McGrath Conspired with ulbricht to deny her disqualification when the notice was not made as a motion pursant to 3-2 -805, MCA. The notice of disqualification contained no affidurit as required of the disqualification for cause statute, Id.; (2) Weiner filed a writ of super-Visory control against the Eleventh Judicial Disctrict court prior to trial. The issues would have resolved the case without going to trial, but Mike McGrath, as well as other justices denied rehearing on the basis that they do not exercise jurisdiction over a lower court in the middle of a trial. However, the trial in the matter had not started until the following monday after the writ was denied; (3) Mike, as well as, Justice James shear, have bios on the Montana Supreme court website indicating they are Catholic. The "ten commandments monument storie was conceived by Catholics and later ver-Sions such as the one removed from Flathead County Public property include Jewish and protestant beliefs. Based on grounds (2) and (2) Combined with this ground, justice Mike McGrath has exhibited egregious misconduct on weimer and Clearly intends to continue to infringe upon Weimer's fundamental rights and harass him.
