Dear David:

The primary purposes of character and fitness screening before admission to the Bar of Montana are to assure the protection of the public and safeguard the justice system. Upon thorough review of your application and background investigation, the Montana Commission on Character and Fitness finds that you have produced satisfactory evidence that you can fulfill these requirements. My records indicate that you have now completed eligibility requirements for admission to the Montana Bar, including submission of qualifying UBE and MPRE scores, have attended the Montana Law Seminar and been certified for character and fitness.
