That cancer has seemed to spread as diagnosed recently and reported by Dr. Tang, Patrick M.D, as Malignant Neoplasm of the head face and throat, attachment 2. This is a terminal type of cancer as it will continue to spread unless treated as Dr. Tang stated by the mayo clinic upon his referral.

The 3rd attachment is from Dr. Taylor recommending that the gastric fermentation syndrome or auto-brewry syndrome also be confirmed by the mayo clinic. The Logan hospital laboratory does not have the suffocated technical ability to identify the microbes that are responsible for fermentation of ethanol in your stomach and intestines. 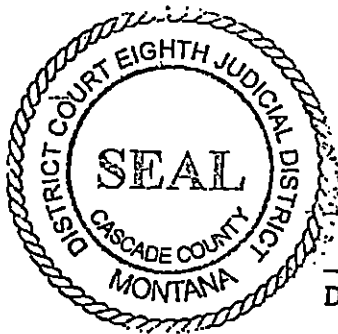
