

RE: *Eligibility for Admission to the State Bar of Montana*

Dear Brenton:

The primary purposes of character and fitness screening before admission to the Bar of Montana are to assure the protection of the public and safeguard the justice system. Upon thorough review of your application and background investigation, the Montana Commission on Character and Fitness finds that you have produced satisfactory evidence that you can fulfill these requirements. My records indicate that you have now completed eligibility requirements for admission to the Montana Bar, including submission of qualifying UBE and MPRE scores, have attended the Montana Law Seminar and been certified for character and fitness. Upon payment of the license tax and dues, you will have fulfilled all requirements for admission.

The Montana Bar collects the license tax on behalf of the Supreme Court Clerk, and those fees must be paid before you are able to be sworn-in. I have enclosed a Member Enrollment form that must be submitted with a check payable to the State Bar of Montana or, if you prefer to pay by credit card, you can contact Jill Diveley, jdiveley@montanabar.org.
