Petitioners in this matter seek a declaratory judgment that Mont. Code Ann. § 15-10-420 requires the Montana Department of Revenue to calculate the statewide levies codified in Mont. Code Ann. §§ 20-9-331, -333, and -360 and 20-25-439 according to the formula provided in subsection (1)(a), does not permit the Department of Revenue to force counties to levy more or less than the calculated mills, and does not permit the Department of Revenue to carry forward mills to future years.
