COMES NOW, Avanlee Okragly, Petitioner/Appellee herein, ("Avanlee") and respectfully submits the following Reply to Appellant's Motion of a three-day extension to file initial brief due to unexpected additional medical issues. An extension should be **denied**, and the appeal dismissed based on Fredrick Keitel's failure to timely file an opening brief. Frederick Keitel has requested several extensions in this case and has failed to file. Separately, I have been harassed by Fredrick Keitel on behalf of his son, Sebastian Keitel starting at 8 weeks gestation after notifying Sebastian of my pregnancy. I have incurred over \$130,000 in legal fees in the last 16 months due to frivolous and non-stop filings by Fredrick Keitel and his son, Sebastian Keitel during our child support proceeding in New York State and custody matter in Montana. I have endured horrific harassment for the duration of my pregnancy, life as a new mom, single mom and business owner.

Of particular concern, the Response fails to address a 20-year restraining order granted in Billings Municipal Court, protecting both Avanlee Okragly and the minor child, A.M.O. from Fredrick Keitel. Frederick Keitel is a disbarred Florida attorney, No. 2018-50,438, who has a violent history of abuse towards anyone that opposes him and continues to harass and threaten despite being sent a no/contact-no/stalking letter by my former counsel. Rick continues to threaten my former counsel with criminal prosecution and has made false reports to the FBI, CPS and law enforcement. The court has noted in our hearings a clear pattern of

harassment, abuse, emotional abuse, and character assassination towards me by both Sebastian Keitel and his father, Frederick Keitel.
