I, Jennifer Dwyer, pursuant to Montana Code Annotated § 1-1-203, declare:
1. I am a licensed, practicing attorney in the State of Montana, and I am currently employed with Avignone, Banick & Williams, PLLC.

In my private practice, I contract with the Office of the Appellate
 Defender. In my capacity as a contract and conflict public defender, I have agreed
 to represent Appellant in this case.

3. A Notice of Appearance was filed on my behalf on October 25, 2023. Appellant's opening brief was first due November 22, 2023. Once I received the district court file, I began to review it and recognized that this record is more extensive, with many lengthy hearings, than almost all previous Youth In Need of Care cases I have handled on appeal in the past. I also realized that there were two companion Youth In Need of Care cases that were referenced by the parties in the district court proceedings. The district court took judicial notice of activity in those companion cases, which was relevant to this appeal. As such, I moved to supplement the record on appeal with the district court record of those companion cases. On November 21, 2023, this Court granted Appellant's request to supplement the record and vacated the deadline to file the Opening Brief. 4. The Clerk of the Supreme Court filed notices indicating that the record on appeal was supplemented on November 29, 2023 and December 1, 2023. The opening brief on appeal is due 30 days from the filing of the complete record on appeal. Thus it is due on January 2, 2024.

5. Since entering my appearance in this matter, I have worked diligently on the case. I have received and reviewed the district court record and transcripts from almost all hearings. I have conducted legal research. I have obtained the district court record in the companion cases and begun to review those as well. Nevertheless, additional time is required to research and draft the opening brief and to confer with Appellant. Additional time is necessary in order to provide effective assistance to Appellant in this matter.

6. Therefore, I respectfully request an additional 30-day extension to file the opening brief in this case, until February 1, 2024.

7. Opposing counsel has been contacted and does not object to the request to extend the time to file the opening brief by thirty days.
