UNOPPOSED MOTION TO SUPPLEMENT THE RECORD AND STAY BRIEFING SCHEDULE

Motion Hearing (Taber)

Mr. Walla's original request for production of transcripts did not include this hearing, which addressed Defense Counsel's opposed motion for a trial continuance to obtain a mental health evaluation concerning Mr. Walla's previously diagnosed condition of combatrelated Post Traumatic Stress Disorder. The District Court granted a continuance, but the existing record on appeal is silent regarding any

rulings on the requested mental health evaluation. Mr. Walla is a veteran. He was convicted of deliberate homicide with a weapons enhancement following a jury trial and then sentenced to a total of 110 years in prison with a 40-year parole restriction. Undersigned counsel believes it is necessary to supplement the record with this transcript to determine whether any meritorious issues exist concerning the requested mental health evaluation.

Judge Oldenburg of the Tenth Judicial District presided over Mr. Walla's trial in the Sixth Judicial District. Court reporters from both judicial districts were involved in transcribing Mr. Walla's various hearings and his trial. Beginning on January 8, 2024, Appellate Defender Division staff sought to identify and get a time estimate for preparing and filing the transcript from the appropriate court reporter.

Earlier this week, ADD learned the Tenth Judicial District's official court reporter, Deidre Taber, will prepare and file the requested transcript herein. Ms. Taber indicates she will need no more than 30 days to file the transcript. Mr. Walla's opening brief is currently due on February 9, 2024.

Mr. Walla respectfully requests this Court order the above-listed

transcript to be filed within 30 days of the Court's order. Mr. Walla also

requests the briefing schedule to be stayed while the transcript is

prepared, with Appellant's opening brief due thirty days after the

requested transcript is filed with this Court. Further, Mr. Walla

requests the Clerk of Court to serve a copy of the Court's order on Ms.

Taber.

The Attorney General's office has been contacted regarding this

motion and has no objection.
