This is Samuel Tintinger, pro se appellant in DA 24-0068.

I hope it is safe to assume you have received the notice of filing in this case. This case is an appeal to the Supreme Court of the State of Montana, case DR-23-811, in which you are the attorney of record for the Petitioner, Ashley Tintinger.

I intend to file a motion pro se requesting the court grant me an extension of time to file my Appellant's Brief. The reason I am asking for this extension is because I am attempting to find proper legal representation.

Thank you for returning my call.

Thank you for letting me know that you do not oppose me requesting more time to write my brief.

Thank you for letting me know you do not oppose me requesting that District Court Judge Leslie Halligan review this decision.

I plan to request that the matter be opened for a second hearing before Judge Halligan so that I may be granted the opportunity to present my testimony adequately.

As you may remember, I informed the court that I have suffered brain trauma, which causes me to have difficulty with communication. You objected to my request to be assisted by my girlfriend Elizabeth Runkle, acting as a communications liason.

I hope you will not object to another hearing being held where further evidence may be entered into this case.

If I am permitted to enter a reasonable and complete testimony, the judge will be able to make a fully informed decision. Presently, I have been denied due process of law.

I will be requesting in my motion that Judge Amy Rubin be removed from this case and related case DR-21-46. I will be asking for a new and complete hearing before Judge Halligan.
