

COMES NOW the Petitioner\Movant, **Scott A. Everard** (EVERARD), Pro-se, and Petitions & Moves this Court for an ORDER TO REINSTATE MONTANA STATE LICENSE TO PRACTICE LAW, for the reasons contained in the subjoined Declaration, and as set forth below.

1. Petitioner has taken and passed the Bar Examinations in the states of Montana, Washington, Idaho & Wyoming.
2. Petitioner contacted the Montana State Bar Office -- KATHY POWERS, MCLE Coordinator, to inquire into the necessary steps to reinstate license to practice law in the State of Montana. Ms. Powers directed, that I needed to supply proof of 30 CLE credits in the last 2-year reporting period. See copy of attached CLE Compliance Affidavit.
3. Petitioner contacted the Montana State Bar Office -- JILL STEILMAN, Membership & Dues Coordinator, to inquire into the necessary steps to reinstate my license to practice law in the state of Montana, and to inquire into license tax delinquency and other formalities. Ms. Steilman directed, I needed to pay past dues with a penalty. I understood from Ms. Steilman that I would need to file a Petition\Motion to reinstate. 4. Petitioner is in compliance with MCLE requirements.

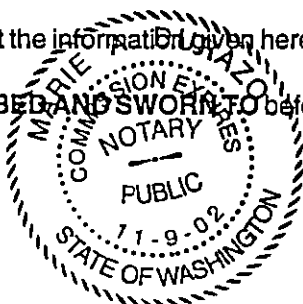




