- 1. I am over the age of 18 years and am competent to testify to the matters set forth herein.

- 2. I am a Montana-licensed attorney and In-House Counsel for Town pump, Inc.
- 3. Austin Lake filed petitions for judicial review of the Unemployment Insurance Appeal Board's decision in the Twentieth Judicial District Court, Cause Nos. DV 2023-76 and DV 2023-77.
- 4. Austin Lake has appealed the Order Dismissing Petition for Judicial Review entered by the Twentieth Judicial District Court in Cause No. DV 2023-77.
- 6. On page 11 of Austin Lake's Opening Brief dated March 27, 2024, Austin Lake states that he is not seeking any relief against or damages from Town Pump, Inc.
- 6.
