PETITION

Comes now, Richard Williamson, and respectfully petitions this Court for reinstatement to active status pursuant to Section 3 of the By-Laws of the State Bar of

Montana.

Petitioner was admitted to the State Bar of Montana on October 1, 2019.

Petitioner was placed on inactive/suspended status by the State Bar of Montana on

July 1, 2024 as a result of noncompliance with CLE requirements.

Petitioner has paid active dues, late fees, reinstatement fees, and the state license tax

to the State Bar of Montana and will comply with any CLE requirements this Court may

impose.

Petitioner has has not been employed as a law clerk while on inactive status.

Petitioner is not currently suspended, disbarred, or otherwise ineligible to practice law in another jurisdiction.

Petitioner is not currently subject to disciplinary proceedings or pending disciplinary proceedings in another jurisdiction.

Petitioner has not been charged with a criminal offense while not on active status.

Petitioner has not accrued delinquent debt or filed for bankruptcy while not on active status.

Petitioner has not failed to fulfill the obligations of public office or professional license (other than as an attorney) while not on active status.

When Petitioner receives a copy on Monday he will file it as a part of this filing as Exhibit 3 so the Court can review it before the Tuesday weekly meeting.

Wherefore, Petitioner requests reinstatement as an active member of the State Bar of Montana.
