of marijuana in DC-87-66.
My sentance is illegal. There are 11 years between the discharge
of DC-87-66 on June 21, 1991 and the felony DUI in DC-02-112 on
August 8, 2002.
April 16, 2003 C.B. McNeil ordered the criminal record of Harlan
Vaska to be corrected on the PSI. The criminal record of Harlan
Gerald Vaska had discrepancies because of the criminal records of

two of Harlan Vaska's brother's were mixed in. Honorable C.B. McNeil ordered Larry Nistler to set the record straight before sentancing May 7, 2003. The Minutes from both April 16, 2003 and May 7, 2003 are attached. I had tryed to accuire a copy of the transcripts from DC-02-112 on April 16, 2003 and May 7, 2003 but denied by the clerk and recorder Connie Costanza. Copy of KITE attached.
