eligibility requirements for the appointment of

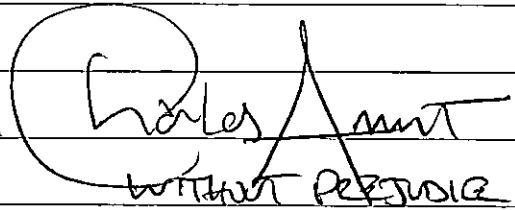
counsel.
