Bar of Montana.

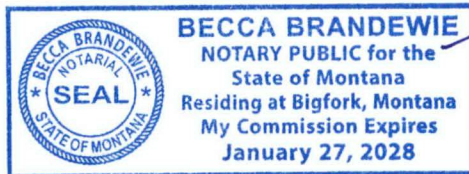
