Appellant Jenny Jing (Jenny), Alice Carpenter (Alice), Mike Bolenbaugh (Mike) respectfully ask this Court to grant a 30 day extension to file their reply brief. The counsels for the opposing parties have stated that they would not object to a 30 day extension.



However, Mike's health issues, resulting from his service in the Vietnam War, limit his ability to engage in more than one hour of concentrated reading or discussion per day.



