ISSUE PRESENTED FOR REVIEW

This Court accepted the appeal of the Kidnapping of the Appellant by officer Nick Ransom

STATEMENT OF THE CASE NUMBER DDV-2024-61

This claim was originally filed in State District Court on January 25, 2024 and the date that the kidnapping occurred was December 3, 2023. The incident arose from the Helena Montana police department working in conjunction with the Lewis and Clark County Sheriff's Office, violating my constitutional rights by invading my property and Kidnapping me without a warrant signed by a judge.

On Wednesday January 1st 2025 Judge Abbott entered a Judgement dismissing the case without ever seeing a single hearing and ordering a \$500.00 fee from the victim to the Kidnapper.

Judge Chris Abbott was my custody judge and should have recused himself from the matter of my Kidnapping.

STATEMENT OF FACTS

This Court accepted the Appeal of The Case of My unlawful Kidnapping.

Around 7 p.m. on December 3rd 2023, Helena police in conjunction with the Lewis and Clark county Sheriffs department, Conspired in and Executed the criminal acts of -

- 1.trespassing
2. illegal search and seizure
- 3.agrivated assault
- 4.abduction/kidnapping
- 5.child endangerment
- 6.detain without bond available
7. false imprisonment
- 8.conspiring and pre-meditating all Crimes listed above numbered 1-7

Montana organized and Pre meditated the Illegal Act of Kidnapping Me.

The Fact they were Working in conjunction Warrants an Investigation by the

Investigations bureau at 2225 11th avenue Helena MT 59601

They knocked on my window. I opened the Door and asked what they wanted.

Officer Nick Ransom responded, "we are here to arrest you".

I replied " do you have a warrant?" to which Nick replied "No"

I said “ you cannot trespass or arrest me without a warrant”

Nick replied “ I don’t need a warrant I have Probable Cause”

I said “ probable cause is what gets you a warrant, so I know for a fact a

judge did not send you here at night so who is responsible for this intrusion on our property?”

Nick Ransom along with all other Law enforcement present said at the same time

“ Kevin Downs”

Nick then forced entry into my home assaulted me and dragged me backwards

outside. Kimber Lowrie my 6 year old daughter terrified, screaming and crying the

most terrible wails you can imagine. She was completely shocked and terrified.

As was I.

He cuffed me and I said let her hug me, they let her hug me. I said to Kimber

“ I’ll be back bug ill bond out.”

Nick Ransom Said “ No you won’t there’s no bond “

I said “everything you are doing right now is against the law”

They ignored me and kidnapped me after that. It was completely Terrifying!

What Law Enforcement did to me that day was unacceptable and illegal.

I should not be expected to Prosecute Officers that break the Law.

Prosecutors should do that. I will do my best to see justice for the pain they

brought my family. I do not have a REFERENCE CASE # OR any Schooling in

Law. But try I will. I don’t understand how something so easy to understand got

Dismissed, but that is very Concerning.

Judge Chris Abbott has since recused himself from my custody case as He should

Have Recused himself from this Issue at hand. There is a clear bias and cruel

Treatment from Judge Abbotts Court toward Kimber and I. we are relieved to be

Done with him!

Argument

I am not an attorney. I am not a prosecutor. I am a Dad, a good Dad.

The defense argues that I did not answer the Discovery. That is a lie I answered it twice. The discovery request I filed was answered in all its entirety with "denied" by the defense for Kevin Downs and the State of Montana attorney

Blake Koemans.

There is no Denying that I was in fact Kidnapped. They did not have a warrant and that is Clearly an Illegal Plan and Act they carried out. The Acts Nick Ransom Lead charge of Cannot go Unanswered. They are clear Violations and Completely Undeniable.

CONCLUSION

In Montana the public duty doctrine has only been applied to cases where the acts of third party tortfeasors result in damage or injuries to Montana citizens.

Public duty doctrine applied protection for Law enforcement from liability for Injuries.

This case is clearly and Vastly different as I was in my Home with my Child.

Officer Ransom Violated Many Laws in his intrusion.

Government officials who commit a direct act of negligence that result in injury to


Montana citizens should have no Blanket of Immunity.


