Declaration of Robert Farris-Olsen


I, Robert Farris-Olsen, declare under penalty of perjury,

1. I am an attorney of record for Intervenors, and I provide this declaration to establish the foundation required for Intervenors' Second Unopposed Motion for Extension of Time under Mont. R. App. P. 25(2)(a)-(f).
2. Intervenors original deadline to file its opening brief was April 18, 2025. Intervenors requested and received an initial 60-day extension under Mont. R. App. P. 26(1), making its Opening Brief now due on June 17, 2025.
3. Before requesting this extension, the undersigned has been working diligently to complete the opening brief, but due to the undersigned having an opening brief due on May 12, 2025, in *Sapphire v. Ravalli County*, DA 25-0164; an opening brief due on May 19, 2025 (filed on May 15, 2025) in *TCLSC v. Lincoln County*, DA-25-0260; and, a opening brief due in *Ambler v. Flathead Conservation District*, Docket Number: 25-1474 in the Ninth Circuit, the task has been burdensome and difficult to complete.
