

- My sentence is illegal because:
- I was sentenced after April 28, 1999, and I received a sentence of more than 5 years to the Department of Corrections, none of which was suspended.
 - My sentence violates my right to be free from double jeopardy.
 - The length of my sentence is longer than the law allows.
 - I am entitled to *either* good time *or* street time that is not credited against my sentence.
 - I am being held in jail and I believe my bail is excessive.
 - Other reason incarceration is illegal.

A Secure Placement Request (SPR) was made against me while my status was a Department of Corrections (DOC) Commit. The SPR was for placement at the Montana State Prison (MSP).

Pursuant to DOC policy and procedure, an SPR must state the reasons for the requested placement. Additionally, if refusal to participate in a program is the reason for the SPR, DOC staff must present a refusal to program form to the inmate to sign. If an inmate refuses to sign, staff must write in the signature block "refused to sign", sign it themselves and attach it to the SPR and document it in the Offender Management Information System (OMIS).

I allege that DOC staff did not present a refusal to program form requesting me to sign it, neither attached such form to the SPR and documented in OMIS, and the reason for the SPR.

I am incarcerated in Mississippi. Six days after arrival to the prison facility on January 29th, 2025, I notified the Warden of no DOC policies and procedures.¹ Access is still not available. I am unable to cite relevant policies and procedures in support of the allegations. I have been harrassed for almost a year by DOC Legal Services Bureau staff on requests for information documented in OMIS also in support of the allegations.²

Jurisdiction over my person transferred from the DOC to the Board of Pardons and Parole (BOPP) upon my placement at MSP. The DOC did not follow policy and procedure for an SPR to have me placed in MSP and therefore should have jurisdiction over my person. The BOPP at an initial parole hearing asserted that challenge as to whether the jurisdiction over my person is lawfully still with the DOC is a court matter.

- Other relief. Explain:




