Comes Now, plaintiff, Eugene Ford, Pro se, in the cause above Number, ADV 2016-770, filed in the First Judicial District Court of Montana, with the Honorable Judge, Mike Menahan, presiding, and asks this Honorable Court for a Writ of Supervisory Control over the above Case. The reason for the request is plaintiff has had no response from Judge, Menahan for over four years in connection with this Case.

Facts

1. This Case was filed in 2016, and was put in STAY in 2020, due to the Covid-19 Pandemic.

2. On September 15,2016, plaintiff filed his complaint.
3. By March,2020, all Discovery, Admissions, Production and Interrogatories were completed, and Expert Witnesses were filed.
4. On April 10,2020, Defense Counsel, filed a Motion for ORDER to STAY CASE and vacate the schedual.
5. On April 15,2020, the court vacated the schedual and issued an ORDER to STAY CASE.
6. Also on April 15,2020, the court recorded plaintiff's request for the Status of the case as plaintiff Ford, was never given a signed court ORDER to STAY CASE and VACATE SCHEDULEAL.
7. Although plaintiff has made numerous attempts Motioning the Court to lift the STAY and RESCHEDULEAL, now that the pandemic is over Judge, Menahan has failed to respond or Lift the STAY.
This actions been silent for over four years now and plaintiff beleaves his 8th Amendment Right to Due Process is being violated.
