UNOPPOSED MOTION TO REMAND TO DISTRICT COURT AND STAY APPEAL

Appellant Clayton Carter respectfully moves the Court to remand this matter to the First Judicial District Court, Lewis and Clark County, for the district court to rule on Carter's pending motion to withdraw his guilty plea filed April 25, 2025. Doc. 99, attached hereto as Exhibit A. The State has been contacted about this motion and does not oppose Mr. Carter's motion.

On January 24, 2025, Mr. Carter pled guilty to assault with a weapon in this matter, DC 24-52. Doc. 114 at 1. On April 3, Mr. Carter filed a pro se letter stating he would like to withdraw his plea and go to trial. Doc. 94. The district court denied the motion because he was

represented by counsel. Doc. 97. On April 25, Mr. Carter, through counsel, filed a motion to withdraw his guilty plea, in which counsel relayed that Mr. Carter contended his plea was coerced and not voluntary and was the result of bad legal advice. *Id.* at 1.

The court sentenced Mr. Carter on April 30. See Doc. 114 at 1. The court ordered the Office of the State Public defender to appoint conflict counsel to represent Mr. Carter, issued a Gilham order, and set a briefing schedule. See Doc. 117 at 1. In the meantime, the court issued its judgment and commitment on May 21, thus starting the clock on Mr. Carter's right to appeal from that judgment. Doc. 114. The court later extended the deadlines associated with Mr. Carter's motion to withdraw. Doc. 119. On July 14, conflict counsel was assigned to represent Mr. Carter below. Doc. 121. Mr. Carter timely filed a notice of appeal of the judgment in this Court on July 15.

This Court has stayed appeals and remanded for the resolution of pending motions to withdraw guilty pleas on several occasions. *See State v. Allen*, DA 22-0651, Order (March 20, 2024); *State v. Collins*, DA 21-0527, Order (January 4, 2022); *State v. Brinson*, DA 07-0392, Order (June 18, 2008); *State v. Moddison*, 278 Mont. 384, 389, 926 P.2d 253,

256 (1996) (noting this Court had remanded for consideration of motion to withdraw guilty plea). Pursuant to this precedent, Mr. Carter requests this Court stay this appeal and remand this case to allow Mr. Carter, through conflict counsel, to finish litigating his pending motion to withdraw his plea. Staying the appeal serves the interests of judicial economy by giving the district court the first opportunity to either allow Mr. Carter to withdraw his pleas and proceed to trial or provide a rationale for denying his request that this Court can review on appeal.

The State does not oppose this motion.
