Mr. Munro and Atty Doggett:

As we have Mr. Doggett on file as your attorney, we can only accept filings from your attorney. We suggest you speak with your attorney about filings and any representation issues you may have. There is no mechanism to “file around” an attorney if you’re unsatisfied with their response. Additionally, the supreme court does not act as a mediator in any dispute you may have with an attorney and their services. If Atty Doggett is no longer your attorney, then he will file a Notice with the Court stating that. Until then, he is the attorney of record.

As far as filing Pro Se, if that occurs, you’ll need to act as your own attorney. Simply put, when you are Pro Se, you are stating you understand the system, have put in the time (or are willing to) needed to understand the system, and will be acting as the attorney in your case. When you represent yourself, you are responsible for all issues in the prosecution of your case. That includes, but is not limited to; strategy, types and procedures for filing, deadlines, proper service notifications, case briefs, transcripts requests and payment (if any), rules of evidence, legal experience, etc. When you call or email the Clerk’s office, it’s likely we will refer you to your attorney in this case – if you elect to represent yourself, that would be you. A professional attorney is in the best position to prosecute your case, submit filings, execute case strategy, has the experience, etc. Please re-read the below yellow highlighted disclaimer from the July 16, 2025, email, and the referral to the Montana State Law Library for Pro Se help. We would advise against acting as your attorney and we strongly suggest you work with Atty Doggett.

Atty Doggett – Could you speak with Mr. Munro about these filings and your role in this matter? Specifically, “Mike Doggett doesn’t believe in facts and truths so he doesn’t represent me for this matter.”

Mr. Munro – please re-read the emails on this thread in their entirety, including this one.

Finally, from the July 16, 2025, email and it applies for this email - **“I have copied your attorney on this email so he may review your submission. It is strongly suggested you speak with Attorney Doggett about this matter and not contact the supreme court directly with this information. Therefore, this email is being returned to you, unfiled.”**
