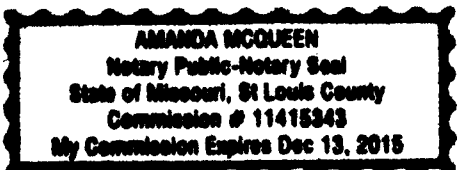

PETITION FOR REINSTATEMENT/STAY OF SUSPENSION

IN RE: Kenneth E. Rudd

1. On March 30, 2013 my Arkansas law license was suspended by vote of the Arkansas Continuing Legal Education Board. I have been notified of that suspension. The basis of the suspension was failure to timely file an out of state certification form as required by Rule 2.(C) of the Arkansas Rules and Regulations for Minimum Continuing Legal Education.
2. Since receiving notification of the suspension, I have not engaged in the active practice of law in the State of Arkansas.
3. There was a problem with our old office management and, unfortunately, my CLE requirements were not filed on a timely basis as a result. There has since been a change in personnel and I am trying to reconcile this issue now that it has come to my attention.
4. I hereby attach payment in the amount of \$25 as a late filing fee. (Fees are Payable to The Bar of Arkansas.)
5. I request that my Arkansas law license be reinstated from the aforementioned suspension for CLE violations. I further request that, pending the Board's determination of reinstatement that there be a stay of my suspension.
