PETITION TO PERMIT STUDENT PRACTICE UNDER THE MONTANA STUDENT PRACTICE RULE

- 1. I am an attorney admitted to practice in this Court and am the attorney of record for the Appellee State of Montana in the above-entitled case.
- 2. I am requesting Ms. Carolyn Sime, of Missoula, Montana, be permitted to appear and practice in this case pursuant to the Rule. See Rule § II. B. (student appearance in criminal matter on behalf of the state), § II. E. 2. (preparation of briefs to be filed in appellate courts), and § II. F. (participation in oral argument in Supreme Court).
